The duty to protect these rights is never ending. Today, religious groups make war on each other. Secular forces attempt to suppress religious belief and human rights are denied by those who want to monopolize speechand thought. Those who carry out such acts of aggression do so in the expectation that it may be possible to eliminate thoughts and beliefs they do not share. Free governments and free peoples must deny that option. They must make it clear that all beliefs are protected, no matter how different.

Your Foundation works to protect these rights and the United Nations Charter calls for Human Rights to be respected without distinction to race, sex, language or religion. As we work to protect these principles, remember that they protect us. If we do not stand up for them, our own beliefs will come under threat.

The dedicated work of institutions like the Appeal of Conscience Foundation is indispensable to the cause of freedom. It is not enough to try to end conflict and stop suffering

important though that is. If, as the United Nations Charter commands, the world's peoples are to live together in peace as good neighbors, the work of eliminating hate and spreading understanding and tolerance must grow and never cease.

Please accept my thanks for your success in this work, I send my thanks as well to the two awardees you honor tonight. In this work, you all have my best wishes for an inspiring occasion.
